2. Test procedure:

- 1) Mark six card holder in No.1, 2, 3, 4, 5, 6.
- 2) Put an IC card into No.1 card holder. Put this card holder gradually close to the reading machine, to see how far the IC card could be read. Mark the distance A.
- 3) Then take the IC card out of the holder. And put this IC card gradually close to the reading machine, to see how far the IC card could be read. Mark the distance B.
- 4) Compare A and B
- 5) Repeat step for card holder No. 2 to 6.


