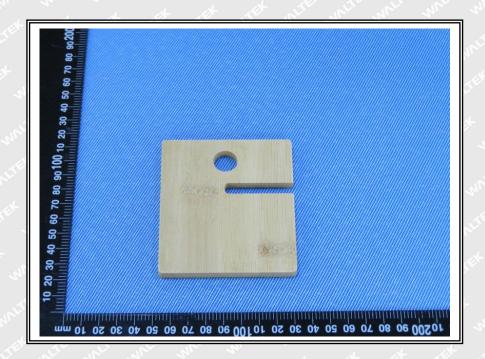

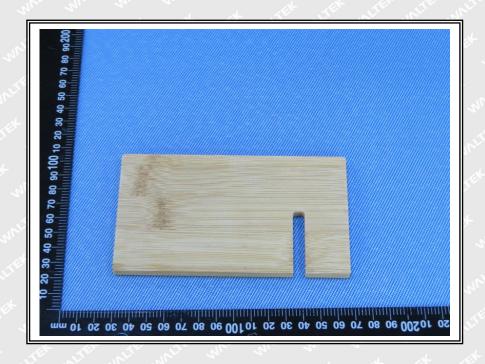
No.1: Yellow wood

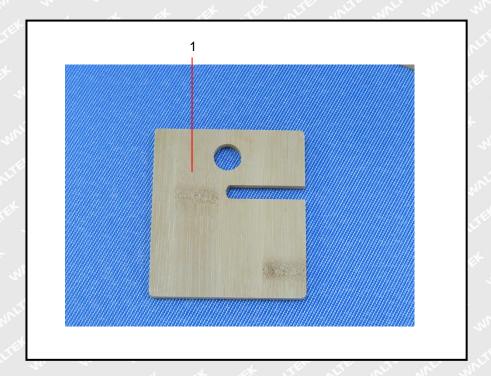
